Choose the month you want to skip, pay a low one-time processing fee of \$35 per loan request, and skip your regular scheduled payment(s) on any GSA FCU consumer loan you have (excluding Visa® credit cards and real estate loans). We'll automatically deduct the processing fee from your share savings account, and if your normal loan payment is deducted through payroll deduction or direct deposit, we'll conveniently credit your account for the appropriate payment(s). If the \$35 processing fee is not available in your share savings account, a check may be mailed along with the Skip-A-Payment coupon below. Requests will not be processed without payment of the \$35 loan processing fee.
